

Building Human Capital in an Aging Mexico

BIOGRAPHIES

Richard Jackson writes on public policy issues arising from the aging of America's and the world's population. He is currently a Senior Fellow at the Center for Strategic and International Studies, where he directs the Global Aging Initiative, an Adjunct Fellow at the Hudson Institute, and a Senior Advisor to the Concord Coalition. In 1996, Jackson helped develop the National Thrift Plan, one of the earliest blueprints for transitioning to a funded system of personally owned Social Security accounts. In 1994, he served as Blackstone Group chairman Peter G. Peterson's liaison to the Kerrey-Danforth Commission on Entitlement and Tax Reform. And from 1988 to 1992, he was a research fellow at the Hudson Institute, where he contributed to the Workforce 2000 project. Jackson is the author of numerous policy studies, including most recently, *The Graying of the Middle Kingdom* (CSIS and Prudential Financial; 2004), *The 2003 Aging Vulnerability Index* (CSIS and Watson Wyatt Worldwide; 2003), and *The Global Retirement Crisis* (CSIS and Citigroup; 2002). Jackson holds a B.A. in classics from SUNY at Albany and a Ph.D. in economic history from Yale University. He lives in Alexandria, Virginia, with his wife Perrine and two children, Benjamin and Brian.

James Jones is Co-Chairman of Manatt Jones Global Strategies. The practice focuses on international trade, investment and commerce, business-government relations and financial services. He specializes in business development advice and consulting for clients primarily in Mexico and Latin America. He has also worked extensively with global distribution and marketing organizations targeting Latin America, Asia and the Middle East. Prior to joining Manatt, Amb. Jones served as U.S. Ambassador to Mexico (1993-1997). He also assisted U.S. businesses with commercial ventures in Mexico. His previous experience also includes the position of President at Warnaco International, as well as Chairman and CEO of the American Stock Exchange in New York (1989-1993). As a member of the U.S. House of Representatives from Oklahoma (1973-1987), Amb. Jones was Chairman of the House Budget Committee and a ranking Member of the House Ways and Means Committee, where he was active in tax, international trade, Social Security and health care policy. Amb. Jones was only 28 when President Lyndon Johnson selected him as Appointments Secretary, the position presently entitled Chief of Staff. He was the youngest person in history to hold this position.

Armand Peschard-Sverdrup is director of the CSIS Mexico Project and responsible for analysis of Mexico's domestic politics, trade, investment, and U.S.-Mexico bilateral relations. He frequently lectures at both the Mexican Advanced Area Studies Seminar at the Foreign Service Institute of the U.S. Department of State and at the National Defense University in Washington, D.C. Among the publications to which he has recently contributed to or authored include, *New Horizons in U.S.-Mexico Relations: Recommendations for Policymakers* (2001), and *Vicente Fox's Cabinet*, with George Grayson, a comprehensive guide to President Fox's cabinet selections (2000). Prior to joining CSIS, Peschard-Sverdrup was senior consultant with Econolynx International in Ottawa, Canada. He also served as a research fellow for the Mexico City bureau of the United Nations Economic Commission for Latin America and the Caribbean (ECLAC). Peschard-Sverdrup did graduate work in government at Georgetown University's School of Foreign Service Center for Latin American Studies and his undergraduate work in political science and economics at Carleton University in Ottawa, Canada.
